### Terms & Conditions

These Terms and Conditions apply to all accounts at Pirate's Cove Marina & Pavilion, LLC. By having an account at Pirate's Cove Marina, you agree to the following terms and conditions:

1. The customer and each guarantor unconditionally, jointly, and severally guarantee full and prompt payment of all sums which may, from time-to-time, be owed to Pirate's Cove Marina as a result of the agreement. Such sums may include all purchases on accounts of products through Pirate's Cove Marina & Pavilion, LLC facilities, and applicable interest, penalties, and service charges.
2. Customer will receive statements weekly, if requested, to the email provided.
3. Customer agrees to pay the full amount due according to the terms indicated on the Pirate's Cove Marina & Pavilion, LLC billing statement. All delinquent accounts shall accrue a finance charge of two percent (2%) per month, or twenty-four percent (24%) per annum. Any payments received will be applied first to outstanding finance charges, then to any past due balance, then to any new purchases.

4. If Pirate's Cove Marina & Pavilion, LLC must use an attorney or collection agency to collect any overdue amount from customer and/or guarantors, customer and each guarantor agree to pay reasonable attorney fees and costs of collection incurred by Pirate's Cove Marina & Pavilion, LLC, plus court costs. In consideration of charges allowed and to be allowed to the customer, the guarantor hereby personally guarantees payments of all amounts due to Pirate's Cove Marina & Pavilion, LLC.
5. Customer must notify Pirate's Cove Marina & Pavilion, LLC of any disputed charge(s) within 15 days after the date of the statement on which such charge(s) appeared. After 15 days, all charges are considered valid and no adjustments will be made. Notice to Pirate's Cove Marina & Pavilion, LLC of a disputed charge shall be given by customer in writing and shall include the following information: Customer's name; the dollar amount of the disputed charge; the reason customer is disputing the charge; and a copy of the statement(s) on which the disputed charge appears. Notice shall be made in writing and mailed to the Pirate's Cove Marina & Pavilion, LLC main office.
6. Pirate's Cove Marina & Pavilion, LLC maintains the absolute right, exercisable in its sole discretion, to interrupt or terminate use of any account issued to Customer.
7. If any portion of this agreement is subsequently held to be valid, such determination shall not affect the other provision of these terms and conditions, which shall remain in full force and effect.

This payment authorization permits payment for any and all charges billed to this account and will remain in effect until cancelled in writing with Pirate's Cove Marina & Pavilion LLC.
